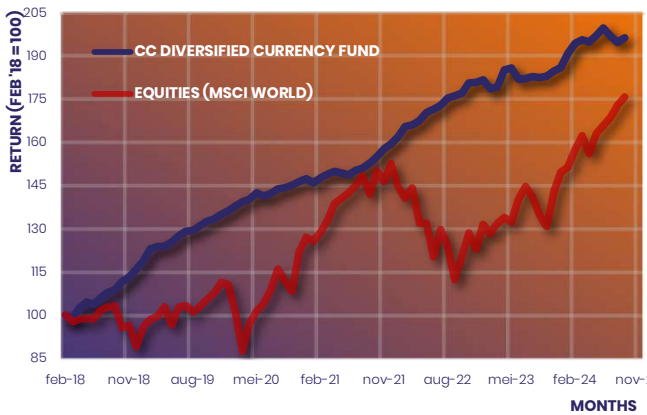

RETURN OF THE FUND AFTER ALL FEES (FEB '18 = 100) VS MSCI WORLD



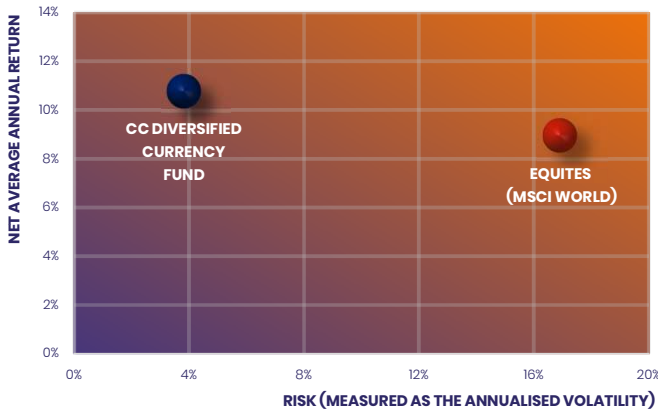
## INVESTMENT APPROACH

The Coeus Diversified Currency Fund trades primarily currency pairs of the G10, but also diversifies through limited investments in gold, equity indices and oil.

However, the Fund Manager does not do this directly. To this end, it has partnered up with Chelton Wealth, which has been very successfully offering managed accounts in this area for years with the help of four expert teams. The fund is thus a logical continuation of these managed accounts in the form of a fund.

The variety of styles of the various expert teams ensures maximum diversification and thus a considerable reduction of risk at the portfolio level.
